#### **RESOLUTION NO. 454-2024**

DECLARING MUNICIPAL ORDINANCE NO. 2023-010 OF THE SANGGUNIANG BAYAN OF TAYUG, PANGASINAN, ENTITLED "AN ORDINANCE RECLASSIFYING A PARCEL OF LAND COVERED BY TRANSFER CERTIFICATE OF TITLE (TCT) NO. T-028-2023000818 WITH A TOTAL AREA OF TWENTY-FIVE THOUSAND (25,000) SQUARE METERS MORE OR LESS LOCATED IN BARANGAY AMISTAD, TAYUG, PANGASINAN FROM AGRICULTURAL LAND USE INTO GENERAL INSTITUTIONAL LAND USE" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT

WHEREAS, the Sangguniang Bayan of Tayug, Pangasinan submitted its Municipal Ordinance No. 2023-10 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer, Provincial Planning and Development Coordinator and the Department of Human Settlements and Urban Development have conducted initial review and study on said municipal ordinance and found out that the same was enacted pursuant to Sections 20 (a) (2) (3) (c) (d) (e) and 447 (a) (2) (viii) of R.A. No. 7160;

WHEREAS, the requisite of public hearing has been complied with and nobody posed no objection on the subject land area proposed for reclassification;

WHEREAS, the Municipality of Tayug has an existing and approved Zoning Ordinance implementing its Comprehensive Land Use Plan CY 2016-2025;

**RESOLVED**, by the Sangguniang Panlalawigan in session assembled, to declare Municipal Ordinance No. 2023-010 of the Sangguniang Bayan of Tayug, Pangasinan, entitled "An Ordinance reclassifying a parcel of land covered by Transfer Certificate of Title (TCT) No. T-028-2023000818 with a total area of twenty-five thousand (25,000) square meters more or less located in Barangay Amistad, Tayug, Pangasinan from agricultural land use into general institutional land use" as within the conferred powers of the Sangguniang Bayan to enact;
