DECLARING MUNICIPAL ORDINANCE NO. 2023-10 OF THE SANGGUNIANG BAYAN OF BINALONAN, PANGASINAN, ENTITLED "AN ORDINANCE PROVIDING FOR THE CREATION OF THE POSITIONS OF ARCHITECT III AND STATISTICIAN II IN THE PLANTILLA OF THE MUNICIPALITY OF BINALONAN, PANGASINAN" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT

WHEREAS, the Sangguniang Bayan of Binalonan, Pangasinan submitted its Municipal Ordinance No. 2023-10 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Local Finance Committee of the Province have conducted initial review and study on said ordinance and found out that the same was enacted in accordance with Sections 76 & 447 (a) (1) and (viii) of R. A. No. 7160;

WHEREAS, it is now incumbent on the part of the Local Chief Executive in coordination with the Municipal Local Finance Committee to prepare a supplemental budget to implement the subject ordinance and a revised plantilla of personnel of the offices concerned be submitted;
