PROVINCIAL RESOLUTION NO. 467-2024

ENDORISING TO THE DEPARTMENT OF HEALTH THE APPLICATION FOR A PERMIT TO CONSTRUCT (PTC) A DIALYSIS CENTER AT THE BAYAMBANG DISTRICT HOSPITAL, PROVINCE OF PANGASINAN

WHEREAS, the Bayambang District Hospital, one of the 14 hospitals operated by the Provincial Government of Pangasinan, caters to patients coming from the different municipalities and other areas from nearby localities of the 3rd District of Pangasinan;

WHEREAS, at present, there is a constant increase in the number of patients being serviced by the hospital;

WHEREAS, the Provincial Government of Pangasinan, through the Bayambang District Hospital, intends to construct a dialysis center that will cater to the growing needs of patients who have to undergo dialysis treatments at affordable costs;

WHEREAS, pursuant to Administrative Order No. 2016-0042, there is a need to secure a Permit to Construct (PTC) from the Department of Health before the construction of a dialysis center to ensure compliance with the guidelines in planning and design of health facilities;

WHEREAS, the Sangguniang Panlalawigan deems it necessary to endorse to the Department of Health the construction of a dialysis center at the Bayambang District Hospital in line with the main thrust of the Provincial Government of Pangasinan to provide affordable dialysis procedures to indigents patients of the Province;

WHEREAS, prior to the issuance of a license to construct, a Provincial Board Resolution is required by the Department of Health to facilitate the issuance of the permit to construct a health facility;

WHEREFORE, on motion of SP Member Shiela Marie F. Baniqued, duly seconded, it was –


