PROVINCIAL RESOLUTION NO. 468-2024

ENDORING TO THE DEPARTMENT OF HEALTH THE APPLICATION FOR A PERMIT TO CONSTRUCT (PTC) A RADIOLOGY DIAGNOSTIC ROOM AT THE MANGATAREM DISTRICT HOSPITAL, PROVINCE OF PANGASINAN

WHEREAS, the Mangatarem District Hospital, one of the 14 hospitals operated by the Provincial Government of Pangasinan, caters to patients coming from the different municipalities and other areas from nearby localities of the 2nd District of Pangasinan;

WHEREAS, the hospital's statistics would show that there is a constant increase in the number of patients being serviced by the hospital;

WHEREAS, the Provincial Government of Pangasinan, through the Mangatarem District Hospital, intends to construct a radiology diagnostic room which is essential for diagnostic imaging using technologies to diagnose illnesses and injuries at health care facilities;

WHEREAS, pursuant to Administrative Order No. 2016-0042, there is a need to secure a Permit to Construct (PTC) from the Department of Health before the construction of a radiology diagnostic room to ensure compliance with the guidelines in planning and design of health facilities;

WHEREAS, in line with the main thrusts of the present administration to have a mass-based health care program to accommodate all people especially the less fortunate sector of society, there is a need to support the plan of the Mangatarem District Hospital to provide a more sufficient and higher level of medical and health services to its patients through the implementation of infrastructure projects;

WHEREFORE, on motion of SP Member Shiela Marie F. Baniqued, duly seconded, it was –


