**RESOLUTION NO. 472-2024**

**DECLARING ORDINANCE NO. 49, SERIES OF 2024 OF THE SANGGUNIANG BAYAN OF AGUILAR, PANGASINAN, ENTITLED "AMENDING SECTIONS II, IV, AND V OF MUNICIPAL ORDINANCE NO. 43, SERIES 2023 ON THE CREATION OF PLANTILLA POSITION OF MUNICIPAL GOVERNMENT DEPARTMENT HEAD I (HUMAN RESOURCE MANAGEMENT OFFICER)" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT**

**WHEREAS**, the Sangguniang Bayan of Aguilar, Pangasinan submitted its Ordinance No. 49, S-2024 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Local Finance Committee and the Civil Service Commission have conducted initial review and study on said municipal ordinance and found out that the same was enacted in accordance with Sections 76 and 447 (a) (1) and (viii) of R.A. 7160 and CSC Memorandum Circular No. 1, S-1997 (Revised Qualification Standards) promulgated on January 24, 1997, and supplemented by amendments outlined in the CSC Memorandum Circular No. 16, S. 2018 (Re: Amendment of the Experience Requirements for Municipal Government Dept. Head Positions) promulgated on September 3, 2018;


