RESOLUTION NO. 473-2024

DECLARING ORDINANCE NO. 224, S-2024 OF THE SANGGUNIANG BAYAN OF BASISTA, PANGASINAN, ENTITLED "AN ORDINANCE NAMING THE EXISTING ARCHES WITHIN THE MUNICIPAL PREMISES TO THE GREAT LEADERS WHO SERVED THE MUNICIPALITY OF BASISTA, PANGASINAN IN THEIR LIFETIME" AS WITHIN THE CONFERRD POWERS OF THE SANGGUNIAN TO ENACT

WHEREAS, the Sangguniang Bayan of Basista, Pangasinan submitted its Ordinance No. 224, S-2024 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer have conducted initial review and study on said municipal ordinance and found out that the same was enacted in accordance with Section 13 of R. A. No. 7160;

WHEREFORE, in view of the foregoing, on motion of SP Members Philip Theodore E. Cruz and Haidee S. Pacheco and co-sponsored by SP Members Carolyn D. Sison, Joyce D. Fernandez, and Raul R. Sabangan, duly seconded, it was-

RESOLVED, by the Sangguniang Panlalawigan in session assembled, to declare Ordinance No. 224, S-2024 of the Sangguniang Bayan of Basista, Pangasinan, entitled "An Ordinance naming the existing arches within the municipal premises to the great leaders who served the municipality of Basista, Pangasinan in their lifetime" as within the conferred powers of the Sangguniang Bayan to enact;
