**RESOLUTION NO. 481-2024**

**DECLARING THE SUPPLEMENTAL BUDGET NO. 3 FOR  
CALENDAR YEAR 2023 OF MANAOAG, PANGASINAN  
INVOLVING A TOTAL APPROPRIATION OF P4,219,777.50,  
OPERATIVE IN ITS ENTIRETY**

**WHEREAS**, pursuant to Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the Sangguniang Panlalawigan of Pangasinan as a legislative body of the Province is empowered to review ordinances authorizing annual or supplemental appropriations of component cities and municipalities in the manner prescribed by law;

**WHEREAS**, the Sangguniang Bayan of Manaoag, Pangasinan submitted its Supplemental Budget No. 3 for Calendar Year 2023 involving total appropriations of P4,219,777.50, which was enacted on December 18, 2023 through Appropriation Ordinance No. 03, Series of 2023;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Local Finance Committee of the Province pursuant to Section 316 of the Local Government Code of 1991, have conducted review and study on said budget with the following findings:

1. That the funding sources for the subject Supplemental Budget were determined in accordance with Section 321 of R.A. No. 7160 and Article 417(a) of its IRR, as amended by Administrative Order No. 47 dated April 12, 1993;
2. That the excess in appropriation for Personal Services shall be subject to Section 325(a) of R.A. No. 7160; and

3. That the grant of Other Personnel Benefits - Service Recognition Incentive (SRI) to government employees for Fiscal Year 2023 shall be in accordance with the provisions of Budget Circular No. 2023-2 dated December 13, 2023 of the Department of Budget and Management.


