RESOLUTION NO. 482-2024

DECLARING MUNICIPAL ORDINANCE NO. 07-2023 OF THE SANGGUNIANG BAYAN OF MANAOAG, PANGASINAN, ENTITLED "AN ORDINANCE INSTITUTIONALIZING THE PHILIPPINE PACKAGE OF ESSENTIAL NON-COMMUNICABLE DISEASES INTERVENTIONS (PHILPEN) ON THE INTEGRATED MANAGEMENT OF HYPERTENSION AND DIABETES MELLITUS IN PRIMARY HEALTH CARE FACILITY IN THE MUNICIPALITY OF MANAOAG, PANGASINAN" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT

WHEREAS, the Sangguniang Bayan of Manaoag, Pangasinan submitted its Municipal Ordinance No. 07-2023 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer and the Local Finance Committee of the Province have conducted initial review and study on said municipal ordinance and found out that the same was enacted in accordance with Sections 16, 17 (b) (2) (iii) and 447 (a) (5) and (xiv) of R. A. No. 7160; Sections 15, Article II (Principles), 11 and Article XIII (Health) of the 1987 Philippine Constitution; Department of Health Administrative Order No. 2011-0003, entitled "National Policy on Strengthening the Prevention and Control of Chronic Lifestyle Related Non-Communicable Diseases; Department of Health Administrative Order No. 2012-0029, entitled "Implementing Guidelines on the Institutionalization of Philippine Package of Essential NCG Interventions (PHILPEN) on the Integrated Management of Hypertension and Diabetes for Primary Health Care Facilities; Department of Health Administrative Order No. 2010-0036, entitled: "The Aquino Health Agenda: Achieving Universal Health Care for All Filipinos";
