RESOLUTION NO. 483-2024

DECLARING MUNICIPAL ORDINANCE NO. 01-09112023 OF THE SANGGUNIANG BAYAN OF POZORRUBIO, PANGASINAN, ENTITLED “AN ORDINANCE UPDATING THE MUNICIPAL REVENUE CODE OF THE MUNICIPALITY OF POZORRUBIO, PANGASINAN” AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT

WHEREAS, the Sangguniang Bayan of Pozorrubio, Pangasinan submitted its Municipal Ordinance No. 01-09112023 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer and the Acting Provincial Treasurer have conducted initial review and study on said municipal ordinance and found out that the same was enacted in accordance with Sections 129, 132 and 191 of R.A. No. 7160;

WHEREAS, the subject ordinance shall take effect after compliance with the requirement of publication pursuant to Sections 188 & 511 of R.A. No. 7160;

WHEREFORE, in view of the foregoing, on motion of SP Members Rosary Gracia P. Perez-Tababa and Nicholi Jan Louie Q. Sison and co-sponsored by SP Members Carolyn D. Sison, Joyce D. Fernandez, and Raul R. Sabangan, duly seconded, it was—

RESOLVED, by the Sangguniang Panlalawigan in session assembled, to declare Municipal Ordinance No. 01-09112023 of the Sangguniang Bayan of Pozorrubio, Pangasinan, entitled “An Ordinance updating the Municipal Revenue Code of the Municipality of Pozorrubio, Pangasinan” as within the conferred powers of the Sangguniang Bayan to enact;


