**APPROVING RESOLUTION NO. 51, S-2024 OF THE SANGGUNIANG BAYAN OF ASINGAN, PANGASINAN, ENTITLED “APPROVING THE MUNICIPAL DEVELOPMENT COUNCIL RESOLUTION NUMBER 1 WITH THE CY 2024 SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM NUMBER 1 OF THE MUNICIPALITY OF ASINGAN, PANGASINAN”**

**WHEREAS**, the Sangguniang Bayan of Asingan, Pangasinan submitted its SB Resolution No. 51, S-2024 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No.7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said SB Resolution with the following findings:

1. Subject resolution is in consonance to Sections 106, 109 and 114 of the Local Government Code (LGC) of 1991. The Local Development Council of Asingan, Pangasinan had identified items in their Supplemental Annual Investment Program (SAIP) No. 1 for CY 2024. This was endorsed to the Sangguniang Bayan for approval on March 1, 2024 by the Municipal Development Council through Resolution No. 1 S-2024;
2. The Supplemental Annual Investment Program No.1 with an investment requirement amounting to Php21,161,108.73 covers fund augmentation for Personal Services, Maintenance and Other Operating Expenses and Capital Outlay of LGU Asingan; and

3. The Sangguniang Bayan enacted Supplemental Budget No. 1 for Calendar Year 2024 through Appropriation Ordinance No.1, Series of 2024 dated March 4, 2024 to support the implementation of the Supplemental Annual Investment Plan No. 1 of the municipality.


