RESOLUTION NO. 486-2024

DECLARING THE SUPPLEMENTAL BUDGET NO. 1 FOR CALENDAR YEAR 2024 OF ASINGAN, PANGASINAN INVOLVING A TOTAL APPROPRIATION OF P21,161,108.73, OPERATIVE IN ITS ENTIRETY

WHEREAS, pursuant to Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the Sangguniang Panlalawigan of Pangasinan as a legislative body of the Province is empowered to review ordinances authorizing annual or supplemental appropriations of component cities and municipalities in the manner prescribed by law;

WHEREAS, the Sangguniang Bayan of Asingan, Pangasinan submitted its Supplemental Budget No. 1 for Calendar Year 2024 involving total appropriations of P21,161,108.73, which was enacted on March 4, 2024 through Appropriation Ordinance No. 01, Series 2024;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Local Finance Committee of the Province pursuant to Section 316 of the Local Government Code of 1991, have conducted review and study on said budget with the following findings:

1. That the funding sources for the subject supplemental budget were determined in accordance to Section 321 of R.A 7160 and Article 414(a) of its IRR as amended by Administrative Order No. 47 dated April 12, 1993;

- 2. That all programs, projects and activities shall be in accordance with the approved Local Development Plan and the FY 2024 Annual Investment Program of the municipality and its supplement thereto formulated pursuant to DILG-NEDA-DBM-DOF Joint Memorandum Circular No. 1, Series of 2017 dated 08 March 2007;
- 3. That all procurements to be undertaken shall be subject to the pertinent provisions of R.A No. 9184 (The Government Procurement Reform Act) and its Implementing Rules and Regulations;
- 4. That the appropriation for Monetization of Leave Credits shall be subject to the provisions of DBM Budget Circular No. 2016-2 dated March 29, 2016 re: Computation and Funding of Monetization of Leave Credits, which provides for the new constant factor stated under 3.1 thereof;
- 5. That the purchase of transportation equipment shall be subject to the provisions of Budget Circular No. 1 2022-1 dated February 11, 2022 re: "Omnibus Guidelines on the Acquisition, Rental & Replacement of Government Motor Vehicles" & Budget Circular No. 2022-1A dated March 1, 2023, (Supplemental Guidelines on the Acquisition, Use, Rental & Replacement of Government Motor Vehicles);
- 6. That the appropriation for additional government share in the premium contribution to the Home Development Mutual Fund (PAG-IBIG FUND) of the municipal officials and employees shall be in accordance pursuant to DBM Circular Letter No. 2024-2 dated February 1, 2024; and
- 7. That the appropriation for Travelling Expenses Foreign shall be in accordance pursuant to Executive Order No. 77 dated March 15, 2019 re: Prescribing Rules and Regulations and Rates of Expenses and Allowances for Official Local and Foreign Travels of Government Personnel.

WHEREAS, the Sangguniang Panlalawigan after final evaluation, finds the same in order provided that the findings shall be complied with by the municipality;
