RESOLUTION NO. 487-2024

DECLARING ORDINANCE NO. 2, SERIES 2024 OF THE SANGGUNIANG BAYAN OF ASINGAN, PANGASINAN, ENTITLED “AN ORDINANCE GRANTING USUFRUCT TO THE REGIONAL TRIAL COURT, THREE HUNDRED SQUARE METERS (300 SQM.) LOT, PARTICULARLY LOT NUMBER 371 OF THE LGU LOCATED IN BETWEEN THE MCTC AND THE GRANDSTAND AT ASINGAN ATHLETIC GROUND, BARANGAY MACALONG, ASINGAN, PANGASINAN” AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT

WHEREAS, the Sangguniang Bayan of Asingan, Pangasinan submitted its Municipal Ordinance No. 2, Series of 2024 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer have conducted initial review and study on said municipal ordinance and found out that the same was enacted in accordance with Section 447 (a) (2) and (v) of R. A. No. 7160;

WHEREAS, a Deed of Usufruct be executed between the Municipal Government of Asingan and the Regional Trial Court to evidence the said grant of usufruct apart from this Ordinance;

WHEREFORE, in view of the foregoing, on motion of SP Members Noel C. Bince and Salvador S. Perez, Jr. and co-sponsored by SP Members Carolyn D. Sison, Joyce D. Fernandez, and Raul R. Sabangan, duly seconded, it was—


