AMENDING PROVINCIAL RESOLUTION NO. 427-2024 AUTHORIZING THE <u>PROVINCE OF PANGASINAN</u> TO OPEN A NEW ACCOUNT WITH THE LAND BANK OF THE PHILIPPINES FOR THE MAINTENANCE OF A SEPARATE ACCOUNT FOR THE PANGASINAN POLYTECHNIC COLLEGE

WHEREAS, the Provincial Government of Pangasinan through Provincial Ordinance No. 300-2023 and amended by Provincial Ordinance No. 314-2024, established the Pangasinan Polytechnic College (PPC) to fully develop the Pangasinenses' intellect and explore their manpower potentials by providing them access and equitable opportunities to post-secondary, college and technical-vocational education with relevant and responsive academic and technology driven programs for all deprived and disadvantaged learners who will be equipped with knowledge, skills, and values to complete and contribute meaningfully to the growth and development of the Province and to the country at a minimal cost;

WHEREAS, at present, the Pangasinan Polytechnic College does not have a separate account for its regular operations and other income-generating endeavors and initiatives:
