RESOLUTION NO. 499-2023

DECLARING MUNICIPAL ORDINANCE NO. 2023-01 OF THE SANGGUNIANG BAYAN OF BOLINAO, PANGASINAN, ENTITLED "AN ORDINANCE INSTITUTIONALIZING A DRUG-FREE WORKPLACE IN THE LOCAL GOVERNMENT OF BOLINAO AND APPROPRIATING FUNDS FOR THE IMPLEMENTATION THEREOF" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT

WHEREAS, the Sangguniang Bayan of Bolinao, Pangasinan submitted its Municipal Ordinance No. 2023-01 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer have conducted initial review and study on said ordinance and found out that the same was enacted in accordance with Section 447 (a) (1) (v) of R.A. No. 7160; Section 2 of R.A. No. 9165, also known as the Comprehensive Dangerous Drugs Act of 2002; and Civil Service Commission Resolution No. 1700653 promulgated on March 15, 2017 (Guidelines on the Conduct of Authorized Drug Testing for Public and Employees);

WHEREAS, the subject ordinance shall take effect after compliance with the requirement of posting pursuant to Section 59 of R.A. No. 7160;

WHEREFORE, in view of the foregoing, on motion of SP Members Napoleon C. Fontelera, Jr. and Apolonia DG. Bacay and co-sponsored by SP Members Carolyn D. Sison, Joyce D. Fernandez and Raul R. Sabangan, duly seconded, it was—
