## **RESOLUTION NO. 503-2024**

## APPROVING RESOLUTION NO. 62, S-2024 OF THE SANGGUNIANG BAYAN OF URBIZTONDO, PANGASINAN, ENTITLED "APPROVING THE REVISED ANNUAL INVESTMENT PROGRAM (AIP) FOR CALENDAR YEAR 2024 OF THE MUNICIPALITY OF URBIZTONDO, PANGASINAN"

WHEREAS, the Sangguniang Bayan of Urbiztondo, Pangasinan submitted its Resolution No. 62, S-2024 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No.7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said Resolution with the following findings:

- 1. The Municipal Disaster Risk Reduction Management Council, through MDRRM Council Resolution No. 01, Series of 2024 dated March 4, 2024, revised their LDRRM Investment Plan to utilize the Unexpended Balances of LDRRM Fund CY 2023 of the LGU;
- The LGU revised their AIP for CY 2024 to include new project to be funded from the 5% LDRRM Unexpended Balances, CY 2023, in the amount of P4,812,700.24. This was endorsed to the Sangguniang Bayan by the Municipal Development Council through MDC Resolution No. 01, S-2024 dated March 13, 2024. This is in accordance to Sections 106, 109 and 114 of the Local Government Code of 1991;

3. The preparation of the Revised AIP is in pursuance to Section 6.5 of the NDRRMC-DILG-DBM JMC No. 2013-1 dated March 25, 2013, to quote:

Section 6.5 The unexpended balances of the LDRRMF may be released and utilized for new expenditure items upon submission of a revised AIP as approved by the Local Sanggunian and Local Chief Eecutive (LCE) upon recommendation of the LDRRMC in accordance with the approved LDRRMP.

4. The project proposed to be funded from the unexpended LDRRM Fund is based on NDRRMC-DILG-DBM JMC No. 2013-1 dated March 25, 2013 (Allocation and Utilization of LDRRM Fund).

WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of Urbiztondo, Pangasinan;

WHEREFORE, in view of the foregoing, on motion of SP Members Philip Theodore E. Cruz and Haidee S Pacheco and co-sponsored by SP Members Carolyn D. Sison, Joyce D. Fernandez and Raul R. Sabangan, duly seconded, it was-
