RESOLUTION NO. 506-2024

DECLARING MUNICIPAL ORDINANCE NO. 3, S-2024 OF THE SANGGUNIANG BAYAN OF URBIZTONDO, PANGASINAN, ENTITLED “AN ORDINANCE CREATING THE LOCAL YOUTH DEVELOPMENT OFFICE (LYDO) ADJUNCT TO THE OFFICE OF THE LOCAL CHIEF EXECUTIVE IN THE MUNICIPALITY OF URBIZTONDO, PANGASINAN” AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT

WHEREAS, the Sangguniang Bayan of Urbiztondo, Pangasinan submitted its Municipal Ordinance No. 3-2024 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer and Local Finance Committee of the Province have conducted initial review and study on said ordinance and found out that the same was enacted in accordance with Sections 443 (c) (2) and 17 (a) (2) (iv) of R.A. 7160 and Section 23 of R.A. No. 10742, otherwise known as the Sangguniang Kabataan (SK) Reform Act of 2015;

WHEREAS, the Local Finance Committee of the Province hereby request that the Ordinance be endorsed to the Office of the Provincial Social Welfare and Development Officer for their further review as to the propriety of the provisions of the same;

WHEREAS, the subject ordinance shall take effect after compliance with the requirement of posting pursuant to Section 59 of R.A. No. 7160;




