APPROVING RESOLUTION NO. 23-91(C) OF THE SANGGUNIANG PANLUNGSOD OF SAN CARLOS CITY, PANGASINAN, ENTITLED “APPROVING AND ADOPTING THE REVISED ANNUAL INVESTMENT PROGRAM FOR CALENDAR YEAR 2023 OF THE CITY GOVERNMENT OF SAN CARLOS (PANGASINAN)”

WHEREAS, the Sangguniang Panlungsod of San Carlos City, Pangasinan submitted its Resolution No. 23-91(C) to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said Resolution with the following findings:

1. The City Disaster Risk Reduction Management Council, through CDRRM Council Resolution No. 02-2023, Series of 2023, prepared the Revised LDRRM Investment Plan to utilize the Unexpended Balances of LDRRM Fund (CYs 2020-2022) of the LGU;
2. This was integrated in the Revised AIP for CY 2023 of the LGU, which was endorsed by the City Development Council of San Carlos City, Pangasinan, through CDC – ExeCom Resolution No. 10-23-A (Series of 2023) dated September 4, 2023 to the Sangguniang Panlungsod for approval. This is in accordance to Sections 106, 109 and 114 of the Local Government Code of 1991;

3. The LGU revised their AIP for CY 2023 to include new projects with a sum of P44,700,000.00, to be funded from the 5% LDRRM Fund Unexpended Balances (CYs 2020, 2021, and 2022) amounting to a total of P48,473,875.14;
4. The proposed projects to be funded from the Unexpended Balances of the LDRRM Fund (CYs 2020, 2021 & 2022) conform with Joint Memorandum Circular No. 2013-1 of the NDRRMC, DBM & DILG dated March 25, 2013 (Allocation and Utilization of the Local Disaster Risk Reduction and Management Fund);
5. The preparation of the Revised AIP is in pursuance to Sections 6.4 and 6.5 of the NDRRMC-DILG-DBM JMC No. 2013-1 dated March 25, 2013, to quote:

Section 6.5 The unexpended balances of the LDRRMF may be released and utilized for new expenditure items upon submission of a revised AIP as approved by the Local Sanggunian and Local Chief Executive (LCE) upon recommendation of the LDRRMC in accordance with the approved LDRRMP.

WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the City Government of San Carlos, Pangasinan;

WHEREFORE, in view of the foregoing, on motion of SP Members Shiela Marie F. Baniqued and Vici M. Ventanilla and co-sponsored by SP Members Carolyn D. Sison, Joyce D. Fernandez and Raul R. Sabangan, it was—

RESOLVED, by the Sangguniang Panlalawigan in session assembled, to approve Resolution No. 23-91(C) of the Sangguniang Panlungsod of San Carlos City, Pangasinan, entitled “Approving and adopting the revised Annual Investment Program for Calendar Year 2023 of the city government of San Carlos (Pangasinan)”;

RESOLVED FURTHER, that a copy of this resolution be furnished the Office of the Sangguniang Panlungsod of San Carlos City, Pangasinan, for its information and guidance.
