DECLARING MUNICIPAL ORDINANCE NO. 2024-02 OF THE SANGGUNIANG BAYAN OF MANGALDAN, PANGASINAN, ENTITLED “AN ORDINANCE AMENDING ORDINANCE NO. 2017-102 “AN ORDINANCE ENACTING THE MARKET CODE OF THE MUNICIPALITY OF MANGALDAN, PROVINCE OF PANGASINAN OF 2017” AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG TO ENACT

WHEREAS, the Sangguniang Bayan of Mangaldan, Pangasinan submitted its Municipal Ordinance No. 2024-02 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer and Acting Provincial Treasurer have conducted initial review and study on said ordinance and found out that the same was enacted in accordance with Sections 447 (a) (1) (iii) (3) (i) (iii) (5) (ii) of R.A. No. 7160 and R.A. No.7394, otherwise known as “Consumer Act”;

WHEREAS, the subject ordinance shall take effect after compliance with the requirement of publication pursuant to Section 511 (a) of R.A. No. 7160;


