RESOLUTION NO. 518-2024

DECLARING ORDINANCE NO. 18, S-2023 OF THE SANGGUNIANG BAYAN OF ASINGAN, PANGASINAN, ENTITLED “AN ORDINANCE RECLASSIFYING TWENTY ONE THOUSAND THREE HUNDRED SIXTY ONE SQUARE METERS (2.1361 HAS.) MORE OR LESS, OWNED BY LOCAL GOVERNMENT UNIT (LGU) OF ASINGAN, PANGASINAN REPRESENTED BY MUNICIPAL MAYOR, ENGR. CARLOS F. LOPEZ, JR. AT BARANGAY CAROSUCAN NORTE, ASINGAN, PANGASINAN COVERED UNDER TCT NUMBER 028- 2021001194 FROM AGRICULTURAL LAND TO RESIDENTIAL USE (PAMBANSANG PABAHAY PARA SA PILIPINO PROGRAM)” AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG TO ENACT

WHEREAS, the Sangguniang Bayan of Asingan, Pangasinan submitted its Ordinance No.18, S-2023 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer, Provincial Planning and Development Coordinator and the Department of Human Settlements and Urban Development have conducted initial review and study on said ordinance and found out that the same was enacted pursuant to Sections 20 (a) (2) (3) (c) (d) (e) and 447 (a) (2) (viii) of R.A. No. 7160;

WHEREAS, the Municipality of Asingan has an existing and approved Zoning Ordinance implementing its Comprehensive Land Use Plan CY 2018-2027;

WHEREAS, the Sangguniang Bayan of Asingan had earlier passed SB Resolution No. 294-B, S-2023 entitled “Resolution Proposing the Reclassification of a Total of Twenty One Thousand Three Hundred Sixty One Square Meters (2.1361 has.) of Land Situated at Barangay Carosucan Norte, Asingan, Pangasinan, Owned by Local Government Unit (LGU) of Asingan, Pangasinan, Represented by Municipal Mayor, Engr. Carlos F. Lopez, Jr. From Agricultural to Residential Use (Pambansang Pabahay Para sa Pilipino Program);

WHEREAS, Clearance for Reclassification (Certifications) from the Department of Agriculture and Department of Agrarian Reform were already accomplished and submitted to the Sangguniang Panlalawigan;



Carlos F. Lopez, Jr. at Barangay Carosucan Norte, Asingan, Pangasinan covered under TCT Number 028– 2021001194 from agricultural land to residential use (Pambansang Pabahay Para sa Pilipino Program)” as within the conferred powers of the Sangguniang Bayan to enact;
