RESOLUTION NO. 519-2024

DECLARING ORDINANCE NO. 17, S-2023 OF THE SANGGUNIANG BAYAN OF ASINGAN, PANGASINAN, ENTITLED “AN ORDINANCE RECLASSIFYING NINE THOUSAND THREE HUNDRED FIFTY SIX SQUARE METERS (0.9356 HA.) MORE OR LESS, OWNED BY CY AGRIFARM CORPORATION, REPRESENTED BY MR. ERIC CHONG, SITUATED AT SITIO LABAC, BARANGAY DUPAC, ASINGAN, PANGASINAN COVERED UNDER TCT NUMBER 028-2022001908 FROM AGRICULTURAL LAND TO AGRO-INDUSTRIAL USE (POULTRY FARM)” AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT

WHEREAS, the Sangguniang Bayan of Asingan, Pangasinan submitted its Ordinance No.17, S-2023 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer, Provincial Planning and Development Coordinator and the Department of Human Settlements and Urban Development have conducted initial review and study on said ordinance and found out that the same was enacted pursuant to Sections 20 (a) (2) (3) (c) (d) (e) and 447 (a) (2) (viii) of R.A. No. 7160;

WHEREAS, the Municipality of Asingan has an existing and approved Zoning Ordinance implementing its Comprehensive Land Use Plan CY 2018-2027;

WHEREAS, the Sangguniang Bayan of Asingan had earlier passed SB Resolution No. 294-A, S-2023 entitled “Resolution proposing the reclassification of a total of Nine Thousand Three Hundred Fifty Six Square Meters (0.9356 Has.) of land situated at Sitio Labac, Barangay Dupac, Asingan, Pangasinan owned by CY Agrifarm Corporation, represented by Mr. Eric Chong from agricultural to agro-industrial use (poultry farm)”;


WHEREAS, Clearance for Reclassification (Certifications) from the Department of Agriculture and Department of Agrarian Reform were already accomplished and submitted to the Sangguniang Panlalawigan;

WHEREFORE, in view of the foregoing, on motion of SP Members Noel C. Bince and Salvador S. Perez, Jr. and co-sponsored by SP Members Carolyn D. Sison, Joyce D. Fernandez, Raul R. Sabangan, duly seconded, it was—


RESOLVED, by the Sangguniang Panlalawigan in session assembled, to declare Ordinance No. 17, S-2023 of the Sangguniang Bayan of Asingan, Pangasinan, entitled “An Ordinance reclassifying Nine Thousand Three Hundred Fifty Six square meters (0.9356 Ha.) more or less, owned by CY Agrifarm Corporation, represented by Mr. Eric Chong, situated at Sitio Labac, Barangay Dupac, Asingan, Pangasinan covered under TCT Number 028-2022001908 from agricultural land to agro-industrial use (Poultry Farm)” as within the conferred powers of the Sangguniang Bayan to enact;
