PROVINCIAL RESOLUTION NO. 521-2024

ADOPTING THE CAMP MANAGEMENT PLAN FOR THE PROVINCE OF PANGASINAN

WHEREAS, RA 10121 or the Philippine Disaster Risk Reduction Management Act of 2010 states that it shall be the policy of the State, among others, to uphold the constitutional rights to life and property by addressing the root causes of vulnerabilities to disasters, strengthening the country's institutional capacity for disaster risk reduction and management, and building the resilience of local communities to disasters including climate change impact;

WHEREAS, RA 10121, in its advocacy and promotion of community-based disaster management, also defines the roles and responsibilities of the members of the national, regional, provincial and city/municipal disaster risk reduction councils;

WHEREAS, DSWD Joint Memorandum Circular (JMC) No. 2, Series of 2021, provides the Guidelines on Camp Coordination and Camp Management and Internally Displaced Person Protection (IDP) requiring the establishment and setting-up of evacuation centers or camps in accordance with existing minimum standards and protocols mainstreaming protection in all camp activities including maintenance of facilities;

WHEREAS, JMC No. 2, Series of 2021 also provides the formulation and adoption of a Camp Management Plan for a guided course of action towards provision of basic and protection services to IDPs in evacuation centers or camps;

WHEREAS, for efficient and functional evacuation centers, there is a need to adopt a Camp Management Plan for the Province of Pangasinan that will be used by the Provincial Social Welfare and Development Office and other concerned offices in managing evacuation centers and in identifying areas of coordination, collaboration and cooperation among other stakeholders to ensure smooth delivery of essential services to the victims of disasters and calamities;

WHEREFORE, on motion of SP Member Vici M. Ventanilla, duly seconded, it was –


