**RESOLUTION NO. 523-2024**

**DECLARING MUNICIPAL ORDINANCE NO. 2023-10 OF THE SANGGUNIANG BAYAN OF AGNO, PANGASINAN, ENTITLED “AN ORDINANCE PROHIBITING GENDER-BASED STREETS AND PUBLIC SPACES SEXUAL HARASSMENT IN THE MUNICIPALITY OF AGNO, PANGASINAN AND PROVIDING PENALTIES FOR VIOLATIONS THEREOF” AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG TO ENACT**

**WHEREAS**, the Sangguniang Bayan of Agno, Pangasinan submitted its Municipal Ordinance No. 2023-10 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer have conducted initial review and study on said municipal ordinance and found out that the same was enacted in accordance with Section 17 (a) & (iv) of R. A. No. 7160; Republic Act No. 11313 or the “Safe Spaces Act”; Republic Act No. 7877 or the “Anti-Sexual Harassment Act of 1995”; Republic Act No. 9208 or the “Anti-Trafficking in Persons Act of 2003”; Republic Act No. 9262 or the “Ant-Violence Against Women and their Children Act of 2004”; Republic Act No. 9995 or the “Anti-Photo and Video Voyeurism Act of 2009”; Republic Act No. 9775 or the “Anti-Child Pornography Act of 2009”; and Republic Act No. 7610 or the “Special Protection of Children Against Abuse, Exploitation and Discrimination Act”;

**WHEREAS**, the subject ordinance shall take effect after compliance with the requirements of posting and publication pursuant to Sections 59 (c) & 511 (a) of R.A. No. 7160;


