DECLARING ORDINANCE NO. 2024-01 OF THE SANGGUNIANG PANLUNGSOD OF ALAMINOS, PANGASINAN, ENTITLED "AN ORDINANCE CHANGING THE POSITION TITLE OF THE POSITION SENIOR ADMINISTRATIVE ASSISTANT V, SG 18/1 UNDER THE TREASURER'S OFFICE TO (LOCAL REVENUE **ADMINISTRATIVE ASSISTANT** V COLLECTION OFFICER III), SG 18/1" AS WITHIN CONFERRED POWERS OF THE SANGGUNIAN TO ENACT
