APPROVING RESOLUTION NO. 77, S-2024 OF THE SANGGUNIANG BAYAN OF INFANTA, PANGASINAN, ENTITLED “APPROVING THE FIRST SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM (AIP) FOR CALENDAR YEAR 2024 OF THE MUNICIPALITY OF INFANTA, PANGASINAN”

WHEREAS, the Sangguniang Bayan of Infanta, Pangasinan submitted its Resolution No. 77, S-2024 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No.7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said Resolution with the following findings:

1. Subject resolution is in consonance to Sections 106, 109 and 114 of the Local Government Code (LGC) of 1991. The Local Development Council of Infanta, Pangasinan has identified items in their First Supplemental Investment Program (SAIP) for CY 2024. This was endorsed to the Sangguniang Bayan on February 26, 2024 through MDC Resolution No. 03, Series of 2024;
2. The said SAIP No. 01 covers fund augmentation for Personal Services and Maintenance and Other Operating Expenses of some municipal government offices, and implementation of development projects and disaster risk reduction and management programs/projects/activities of the LGU;

3. Funding support for the proposed SAIP, with a total investment requirement of Php21,735,176.60 is embodied in the municipality's Supplemental Budget No. 1, CY-2024, amounting to Php15,710,813.27, which was approved and enacted by their Sangguniang Bayan on April 11, 2024 through Appropriation Ordinance No. 01, Series of 2024. The remaining Php6,024,363.33 will be funded under the LDRRMF CY 2023 unexpended balance (PhP5,746,020.94), BFP Trust Fund (PhP178,342.39), and OMAG Trust Fund (PhP100,000.00); and
4. The identified programs/projects/activities funded out of the unexpended 5% Local Disaster Risk Reduction and Management Fund of the municipality conforms with Section 21 of RA 10121 and NDRRMC-DBM and DILG Memo Circular No. 2013-1 dated March 25, 2013 (Allocation and Utilization of Local Disaster Risk Reduction and Management Fund).

WHEREAS, however, the LGU is advised to observe Section 6.5 of the NDRRMC-DBM-DILG Joint Memorandum Circular No. 2013-1 dated March 25, 2015 of the Department of the Interior and Local Government, to quote: The unexpended balances of the LDRRMF may be released and utilized for new expenditure items upon submission of a revised AIP as approved by the local sanggunian and Local Chief Executive (LCE), upon recommendation of the LDRRMC in accordance with the approved LDRRMP;

WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of Infanta, Pangasinan;

WHEREFORE, in view of the foregoing, on motion of SP Members Napoleon C. Fontelera, Jr. and Apolonia DG. Bacay and co-sponsored by SP Members Carolyn D. Sison, Joyce D. Fernandez and Raul R. Sabangan, duly seconded, it was—

RESOLVED, by the Sangguniang Panlalawigan in session assembled, to approve Resolution No. 77, S-2024 of the Sangguniang Bayan of Infanta, Pangasinan, entitled “Approving the First Supplemental Annual Investment Program (AIP) for Calendar Year 2024 of the municipality of Infanta, Pangasinan”;


