APPROVING RESOLUTION NO. 2024-121 OF THE SANGGUNIANG BAYAN OF SISON, PANGASINAN, ENTITLED "APPROVING THE 1ST SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM-CY 2024 OF THE MUNICIPALITY OF SISON, PANGASINAN"

WHEREAS, the Sangguniang Bayan of Sison, Pangasinan submitted its Resolution No. 2024-121, Series of 2024 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No.7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said Resolution with the following findings:

1. Subject resolution is in consonance to Sections 106, 109 and 114 of the Local Government Code (LGC) of 1991. The Municipal Development Council of Sison, Pangasinan has identified items in their 1st Supplemental Annual Investment Program. This was endorsed to the Sangguniang Bayan for approval on March 18, 2024 by the Municipal Development Council-Executive Committee thru Resolution No. 01-2024, Series of 2024;
2. The SAIP covers fund augmentation for Personal Services, Maintenance and Other Operating Expenses and Capital Outlay of various Municipal offices and the implementation of priority programs and projects of the LGU with the total investment requirement of Php51,188,939.05; and

- Funding support for the full implementation of the same is embodied in their proposed Supplemental Budget No. 1 for Calendar Year 2024 which was enacted by their Sangguniang Bayan thru Appropriation Ordinance No. 01 on April 1, 2024 and approved by the Municipal Mayor on April 4, 2024.

WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of Sison, Pangasinan;


