PROVINCIAL RESOLUTION NO. 544-2024

AUTHORIZING THE PROVINCIAL GOVERNOR, RAMON V. GUICO III, TO ENTER INTO AND SIGN A MEMORANDUM OF AGREEMENT (MOA) WITH TEAM ENERGY FOUNDATION, INC. (TEFI) FOR THE DONATION OF FOUR (4) UNITS OF SERVICE VEHICLE (2024 TOYOTA HILUX FX) TO THE PROVINCE OF PANGASINAN

WHEREAS, the Team Energy Corporation, through its social development arm, the Team Energy Foundation, Inc. (TEFI), has been steadfast in helping the Provincial Government of Pangasinan implement projects that are beneficial to the Province and its people;

WHEREAS, the Province of Pangasinan is a host province to the Sual Coal-Fired Thermal Power Plant;

WHEREAS, TEFI will provide four (4) units of 2024 Toyota Hilux FX with Rear A/C Vehicles to the Province of Pangasinan with an estimated total project cost of Four Million Seven Hundred Forty-Five Thousand Eight Hundred and Ninety-Two Pesos (P4,745,892.00);

WHEREAS, the Province of Pangasinan which is engaged in meaningful tourism development and investment promotion will greatly benefit from the project;

WHEREAS, the service vehicles can be used primarily and effectively to further enhance various tourism, investment promotion and livelihood programs in the Province of Pangasinan towards achieving better and more accessible ways of serving the people of Pangasinan;

WHEREAS, for the above purpose, a Memorandum of Agreement shall be entered into and signed between the Province of Pangasinan, represented by Governor Ramon V. Guico III, and the Team Energy Foundation, Inc., represented by its Officer-in-Charge, Mitsuhiro Kojima;

NOW, THEREFORE, on motion of SP Member Vici M. Ventanilla, duly seconded, it was –


