#### PROVINCIAL RESOLUTION NO. 546-2024

AUTHORIZING THE PROVINCIAL GOVERNOR, RAMON V. GUICO III, TO NEGOTIATE AND SIGN ON BEHALF OF THE PROVINCE OF PANGASINAN, THE DEED OF ABSOLUTE SALE FOR THE PURCHASE OF PARCEL OF LAND, COVERED BY TAX DECLARATION NO. 11-0021-22871 TO BE UTILIZED AS THE PROPOSED SITE FOR THE CONSTRUCTION OF RECREATIONAL AREA AND BARANGAY HALL

WHEREAS, the Local Government Code of 1991 (R.A. 7160), in Chapter II, Section 16 thereof, provides "xxx that every local government unit shall exercise powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare xxx ";

WHEREAS, Chapter II, Section 22 (a)(4) of the same Code provides that every local government unit, as a corporation, shall have the powers to "acquire and convey real or personal property";

WHEREAS, the Provincial Government of Pangasinan intends to acquire parcel of land located in Brgy. Sto. Niño, Binalonan, Pangasinan, to be utilized as the proposed site for the construction of recreational area and barangay hall, covered by Tax Declaration No. 11-0021-22871, which previously cancelled Tax Declaration No. 11-0021-01031, registered in the name of Elisea Casaclang Dres, Vivian Casaclang Dres and Vanessa Dres Griffith, covering an area of 1,215 square meters, more or less;

WHEREAS, an ocular inspection of the lot has been conducted by the Provincial Appraisal Committee (PAC), and pursuant to Resolution No. 37-3023, it was resolved that the just and recommended equitable valuation of the subject properties be valued as follows:
