RESOLUTION NO. 547-2024

APPROVING RESOLUTION NO. 116, S-2024 OF THE SANGGUNIANG BAYAN OF BINMALEY, PANGASINAN, ENTITLED "APPROVING THE SUPPLEMENTAL INVESTMENT PROGRAM NO. 1 FOR CY 2024 OF THE MUNICIPALITY OF BINMALEY, PANGASINAN"

WHEREAS, the Sangguniang Bayan of Binmaley, Pangasinan submitted its SB Resolution No. 116, S-2024 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No.7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said SB Resolution with the following findings:

1. The Municipal Development Council of Binmaley, Pangasinan prepared their Supplemental Investment Program (SIP) No. 1 for CY 2024. This was endorsed by the Council, through MDC Resolution No. 1, Series of 2024, dated March 8, 2024, to the Sangguniang Bayan for approval;
2. Said Supplemental Annual Investment Program, which has a total investment requirement of ₱5,600,000.00, covers the Purchase of rescue vehicles for disaster response; and
3. The new/proposed projects to be funded from realignment of funds under the 5% MRDDM Fund conform with Joint Memorandum Circular No. 2013-1 of the NDRRMC, DBM & DILG dated March 25, 2013 (Allocation and Utilization of the Local Disaster Risk Reduction and Management Fund).


