DECLARING MUNICIPAL ORDINANCE NO. 3, S-2024 OF THE SANGGUNIANG BAYAN OF BINMALEY, PANGASINAN, ENTITLED "AN ORDINANCE ADOPTING THE GUIDELINES AND POLICIES FOR THE BINMALEY RESETTLEMENT PROJECT LOCATED IN BARANGAY PAPAGUEYAN, BINMALEY, PANGASINAN" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG TO ENACT


