RESOLUTION NO. 550-2024

DECLARING ORDINANCE NO. 086, S-2024 OF THE SANGGUNIANG BAYAN OF LABRADOR, PANGASINAN, ENTITLED "AN ORDINANCE ENACTING THE REVISED GENDER AND DEVELOPMENT CODE OF THE MUNICIPALITY OF LABRADOR, PANGASINAN" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT

WHEREAS, the Sangguniang Bayan of Labrador, Pangasinan submitted its Ordinance No. 086, S-2024 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer have conducted initial review and study on said ordinance and found out that the same was enacted in line with the national policies and principles of the Gender and Development Code of the Philippines enshrined in the 1987 Philippine Constitution as well as the Gender and Development Code of the Province of Pangasinan; Republic Act No. 7192 (An Act Promoting the Integration of Women as Full and Equal Partners of Men in Development and Nation Building and for Other Purposes) and Sections 16 and 17 (a) and (iv) of R.A. No. 7160;

WHEREAS, subject ordinance shall take effect after compliance with the requirement of posting pursuant to Section 59 of R.A. No. 7160;

WHEREFORE, in view of the foregoing, on motion of SP Members Philip Theodore E. Cruz and Haidee S. Pacheco and co-sponsored by SP Members Carolyn D. Sison, Joyce D. Fernandez and Raul R. Sabangan, duly seconded, it was—


