APPROVING RESOLUTION NO. 23-085 OF THE **SANGGUNIANG PANLUNGSOD** OF SAN CARLOS. "APPROVING PANGASINAN, **ENTITLED** SUPPLEMENTAL INVESTMENT PROGRAM (SIP) NO. 6 FOR CALENDAR YEAR 2023 OF THE CITY OF SAN CARLOS, PROVINCE OF PANGASINAN"

WHEREAS, the Sangguniang Panlungsod of San Carlos, Pangasinan submitted its Resolution No. 23-085 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No.7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said SB Resolution with the following findings:

- The City Development Council of San Carlos City, Pangasinan prepared the Supplemental Investment Program (SIP) No. 6, CY 2023. This was endorsed by the Council, through CDC ExeCom Resolution No. 08-23 (Series of 2023) dated August 15, 2023, to the Sangguniang Panlunsod for approval. This is in accordance to Sections 106, 109 and 114 of the Local Government Code of 1991;
- 2. The Supplemental Investment Program (SIP), which has a total investment requirement of ₱199,953,746.00, covers the implementation of various infrastructure priority projects of the LGU. Funding support for the Supplemental AIP will be sourced from the proceeds of the loan of the LGU from the Land Bank of the Philippines;

3. The project identified in the SIP are listed in the Loan Agreement between the City LGU and the Land Bank of the Philippines.
