#### **RESOLUTION NO. 558-2024**

DECLARING THE SUPPLEMENTAL BUDGET NO. 4 FOR CALENDAR YEAR 2023 OF THE SANGGUNIANG PANLUNGSOD OF SAN CARLOS, PANGASINAN, INVOLVING TOTAL APPROPRIATIONS OF PHP199,953,746.00, OPERATIVE IN ITS ENTIRETY

WHEREAS, pursuant to Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the Sangguniang Panlalawigan of Pangasinan as a legislative body of the Province is empowered to review ordinances authorizing annual or supplemental appropriations of component cities and municipalities in the manner prescribed by law;

WHEREAS, the Sangguniang Panlungsod of San Carlos, Pangasinan submitted its Supplemental Budget No. 4 for Calendar Year 2023 involving total appropriations of PHP199,953,746.00, which was enacted on September 4, 2023 through Appropriation Ordinance No. 23-34;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Local Finance Committee of the Province pursuant to Section 316 of the Local Government Code of 1991, have conducted review and study on said budget with the following findings:

That the total fund source available for supplemental appropriation (i.e. Proceeds from Loan from the Land Bank of the Philippines (LBP) will be made actually available as required under Article 417(a) of the IRR of R.A. No. 7160, as amended by Administrative Order No. 47 dated April 12, 1993, and as contained in the Omnibus Term Loan Agreement between the LBP and the City Government of San Carlos;

- That all programs, projects and activities shall be in accordance with the approved Local Development Plan and the FY 2023 Supplemental Investment Program of the city formulated pursuant to DILG-NEDA-DBM-DOF Joint Memorandum Circular No. 1, Series of 2007 dated 08 March 2007; and
- 3. That all procurements to be undertaken shall be subject to the pertinent provisions of R.A. No. 9184 (The Government Procurement Reform Act) and its Implementing Rules and Regulations.

**WHEREAS**, the Sangguniang Panlalawigan after final evaluation, finds the same in order provided that the findings shall be complied with by the City;

WHEREFORE, in view of the foregoing, on motion of SP Members Shiela Marie F. Baniqued and Vici M. Ventanilla and co-sponsored by SP Members Carolyn D. Sison, Joyce D. Fernandez and Raul R. Sabangan, duly seconded, it was—
