**RESOLUTION NO. 573-2024**

**DECLARING MUNICIPAL ORDINANCE NO. 5, S-2024 OF THE SANGGUNIANG BAYAN OF URBIZONDO, PANGASINAN, ENTITLED “AN ORDINANCE ESTABLISHING THE WETLANDS OR WATER BODY LOCATED AT BARANGAYS TRAVERSED BY BINALATONGAN RIVER, LOCOT RIVER, AGNO RIVER AND KALIWAKIW FISHPOND, URBIZONDO, PANGASINAN AS A REGULATED AREA AND FOR PROTECTION PURPOSES IN THE MUNICIPALITY OF URBIZONDO, PANGASINAN AND PROVIDING PENALTIES FOR VIOLATION THEREOF” AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG TO ENACT**

**WHEREAS**, the Sangguniang Bayan of Urbiztondo, Pangasinan submitted its Ordinance No. 5, S-2024 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer have conducted initial review and study on said municipal ordinance and found out that the same was enacted in accordance with Sections 17 (a) (b) (2) (i) and 447 (1) (iii) of R. A. No. 7160; R.A. No. 9275, otherwise known as the “Philippine Clean Water Act of 2004”; and R.A. No. 7586 or the “National Integrated Protected Areas System Act of 1992”;

**WHEREAS**, the subject ordinance shall take effect after compliance with the requirement of publication pursuant to Section 511 (a) of R.A. No. 7160;

**WHEREFORE**, in view of the foregoing, on motion of SP Members Philip Theodore E. Cruz and Haidee S. Pacheco and co-sponsored by SP Members Carolyn D. Sison, Joyce D. Fernandez and Raul R. Sabangan, duly seconded, it was—


