**RESOLUTION NO. 574-2024**

**DECLARING MUNICIPAL ORDINANCE NO. 2024-02 OF THE SANGGUNIANG BAYAN OF ALCALA, PANGASINAN, ENTITLED “AN ORDINANCE REQUIRING ALL COUPLES IN THE MASS WEDDING ACTIVITY OF THE MUNICIPALITY OF ALCALA, PANGASINAN TO PLANT AND NURTURE FAST-GROWING TREES AS A PRE-REQUISITE FOR SECURING PRE-MARRIAGE COUNSELING CERTIFICATE” AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG TO ENACT**

**WHEREAS**, the Sangguniang Bayan of Alcala, Pangasinan submitted its Ordinance No. 2024-02 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer have conducted initial review and study on said ordinance and found out that the same was enacted in accordance with Sections 16, 17 (b) (i) and 447 (5) (i) of R.A. No. 7160;

**WHEREFORE**, in view of the foregoing, on motion of SP Members Rosary Gracia P. Perez-Tababa and Nicholi Jan Louie Q. Sison and co-sponsored by SP Members Carolyn D. Sison, Joyce D. Fernandez and Raul R. Sabangan, duly seconded, it was—

**RESOLVED**, by the Sangguniang Panlalawigan in session assembled, to declare Ordinance No. 2024-02 of the Sangguniang Bayan of Alcala, Pangasinan, entitled “An Ordinance requiring all couples in the mass wedding activity of the Municipality of Alcala, Pangasinan to plant and nurture fast-growing trees as a pre-requisite for securing pre-marriage counseling certificate” as within the conferred powers of the Sangguniang Bayan to enact;


