**WHEREAS**, Section 17, of Art II of 1987 Philippines Constitution provides that “The State shall give priority to education science and technology, arts, culture and sports to foster patriotism and nationalism, accelerate social progress and promote total human liberation and development”

**WHEREAS**, the Philippine Teachers Professionalization Act of 1994 or the Republic Act No. 9293 as amended provides that it is a requirement for all applicants for a license to pass the Licensure Examination for Teachers conducted by the Professional Regulatory Commission (PRC);

**WHEREAS**, a total of 50,539 out of 85,980 (58.78%) applicants successfully passed the Licensure Examination for Professional Teachers held last March 17, 2024;

Polong Norte, Malasiqui, Pangasinan and a degree holder of Bachelor of Secondary Education Major in Mathematics at Pangasinan State University, Bayambang Campus who at the same time hailed as Cum Laude of Magnayon Class of 2023;


