PROVINCIAL RESOLUTION NO. 588-2024

AUTHORIZING THE PROVINCIAL GOVERNOR, RAMON V. GUICO III, TO ENTER INTO AND SIGN A DEED OF DONATION AND ACCEPT ONE (1) MOBILE LABORATORY AND CLINIC THROUGH THE MOBILE PRIMARY CARE FACILITY (MPCF) HEALTH PROGRAM OF THE DEPARTMENT OF HEALTH

WHEREAS, Republic Act No. 11223, otherwise known as the Universal Health Care Act (UHC Act), seeks to progressively realize universal health care in the country through a systematic approach and clear delineation of the roles of key agencies and stakeholders toward better performance in the health system;

WHEREAS, the Department of Health (DOH), as the principal agency of the government responsible for ensuring essential public health services, has signified its intention to address the evolving healthcare needs of the Provincial Government of Pangasinan through the provisions of health care services and facilities under its Mobile Primary Care Facility (MPCF) health program;

WHEREAS, the Mobile Primary Care Facility (MPCF) health program of the Department of Health aims to provide timely and accessible medical care to the Filipino people;

WHEREAS, the Province of Pangasinan will be the recipient of one (1) Mobile Laboratory and Clinic from the Department of Health in the form of a donation and hereby expresses its willingness to accept the same;

WHEREAS, the said mobile health facility can be used primarily and effectively by the Provincial Government of Pangasinan to cater and respond immediately to the health necessities of the people in both routine and emergency situations;

WHEREAS, it is to the best interest of the provincial government to sign the Deed of Donation and accept the mobile and laboratory clinic from the DOH to augment the need for medical extension services of the government hospitals of Pangasinan;

NOW, THEREFORE, on motion of SP Member Shiela Marie F. Baniqued, duly seconded, it was –


