RESOLUTION NO. 593-2024

DECLARING ORDINANCE NO. 2024-05 OF THE SANGGUNIANG PANLUNGSOD OF ALAMINOS, PANGASINAN, ENTITLED “AN ORDINANCE GOVERNING THE USE, SALE AND DISTRIBUTION OF FIRECRACKERS AND PYROTECHNIC DEVICES IN THE CITY OF ALAMINOS, PANGASINAN” AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG TO ENACT

WHEREAS, the Sangguniang Panlungsod of Alaminos City, Pangasinan submitted its City Ordinance No. 2024-05 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer have conducted initial review and study on said city ordinance and found out that the same was enacted in accordance with Sections 16, 458 (a) (1) (ii) of R.A. No. 7160, Sections 1 and 4 of R.A. No. 7183, otherwise known as the “An Act Regulating the Sale, Manufacture, Distribution and Use of Firecrackers and Other Pyrotechnic Devices”;

WHEREAS, the subject ordinance shall take effect after compliance with the requirement of publication pursuant to Section 511 (a) of R.A. No. 7160;

WHEREFORE, in view of the foregoing, on motion of SP Members Napoleon C. Fontelera, Jr. and Apolonia DG. Bacay and co-sponsored by SP Members Carolyn D. Sison, Joyce D. Fernandez and Raul R. Sabangan, duly seconded, it was—


