RESOLUTION NO. 595-2024

DECLARING MUNICIPAL ORDINANCE NO. 28, S-2023 OF THE SANGGUNIANG BAYAN OF ANDA, PANGASINAN, ENTITLED “AN ORDINANCE UPDATING THE CHILDREN AND YOUTH WELFARE CODE OF THE MUNICIPALITY OF ANDA, PANGASINAN” AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG TO ENACT

WHEREAS, the Sangguniang Bayan of Anda, Pangasinan submitted its Municipal Ordinance No. 28, S-2023 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer have conducted initial review and study on said municipal ordinance and found out that the same was enacted in accordance with PD 603 (The Child and Youth Welfare Code); R.A. No.7610 of 1992 (Special Protection of Children Against Child Abuse, Exploitation, and Discrimination Act), otherwise known as the “Child Protection Law”, and Section 17 (b) (2) (iii) (iv) (5) (xiv) of R.A. No. 7160;

WHEREAS, the subject ordinance shall take effect after compliance with the requirement of publication pursuant to Section 511 (a) of R.A. No. 7160;

WHEREFORE, in view of the foregoing, on motion of SP Members Napoleon C. Fontelera, Jr. and Apolonia DG. Bacay and co-sponsored by SP Members Carolyn D. Sison, Joyce D. Fernandez and Raul R. Sabangan, duly seconded, it was—


