**RESOLUTION NO. 596-2024**

**DECLARING ORDINANCE NO. 226, S-2024 OF THE SANGGUNIANG BAYAN OF BASISTA, PANGASINAN, ENTITLED "AN ORDINANCE UPDATING SECTIONS 4, 15, 16 & 80 OF MUNICIPAL ORDINANCE NO. 92, SERIES OF 2017, ENTITLED "AN ORDINANCE ENACTING THE GENDER AND DEVELOPMENT CODE OF THE MUNICIPALITY OF BASISTA, PROVINCE OF PANGASINAN" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT**

**WHEREAS**, the Sangguniang Bayan of Basista, Pangasinan submitted its Municipal Ordinance No. 226, S-2024 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer have conducted initial review and study on said ordinance and found out that the same was enacted in line with the national policies and principles of the Gender and Development Code of the Philippines enshrined in the 1987 Constitution; Gender and Development Code of the Province of Pangasinan; R.A. No. 7192 (An Act Promoting the Integration of Woman as Full and Equal Partners of Men in Development and Nation Building and for Other Purposes); Sections 16, 17 (a) (iv) of R. A. No. 7160; Section 6, Item (g) R.A. No. 7610 of 1992 (Special Protection of Children Against Child Abuse, Exploitation, and Discrimination Act), otherwise known as the "Child Protection Law); and Section 45 (b) (b.4) of R.A. No. 9710 (Magna Carta of Women);

**WHEREAS**, the subject ordinance shall take effect after compliance with the requirement of publication pursuant to Section 511 (a) of R.A. No. 7160;
