RESOLUTION NO. 597-2024

DECLARING TAX ORDINANCE NO. 003-2023 OF THE SANGGUNIANG BAYAN OF LABRADOR, PANGASINAN, ENTITLED "AN ORDINANCE ENACTING THE 2023 REVISED REVENUE CODE OF THE MUNICIPALITY OF LABRADOR, PANGASINAN" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG TO ENACT

WHEREAS, the Sangguniang Bayan of Labrador, Pangasinan submitted its Municipal Ordinance No. 003-2023 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer and Acting Provincial Treasurer have conducted initial review and study on said ordinance and found out that the same was enacted in accordance with Sections 129, 132 and 191 of R.A. No. 7160;

WHEREAS, the subject ordinance shall take effect after compliance with the requirements of posting and publication pursuant to Sections 59 (c), 511 (a) and 188 of R.A. No. 7160;


