RESOLUTION NO. 607-2024

**DECLARING THE ANNUAL BUDGET FOR CY 2024 OF
URDANETA CITY, PANGASINAN INVOLVING A TOTAL
APPROPRIATION OF P1,600,537,932.00, OPERATIVE IN ITS
ENTIRETY**

WHEREAS, pursuant to Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the Sangguniang Panlalawigan of Pangasinan as a legislative body of the Province is empowered to review ordinances authorizing annual or supplemental appropriations of component cities and municipalities in the manner prescribed by law;

WHEREAS, the Sangguniang Panlungsod of Urdaneta City, Pangasinan submitted its Annual Budget for Calendar Year 2024 involving total appropriations of P1,600,537,932.00 which was enacted on November 16, 2023 through Appropriation Ordinance No. 44, Series of 2022-25;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Local Finance Committee of the Province pursuant to Section 316 of the Local Government Code of 1991, have conducted review and study on said budget with the following findings:

1. That the grant of step increments to city officials and employees and elective officials shall be subject to the provisions of Civil Service Commission (CSC) and Department of Budget and Management (DBM) Joint Circular No. 1, S. 2012 and JC No. 1, S. 2016 dated September 3, 2012 and January 27, 2016, respectively;
2. That the appropriation for Productivity Incentive Allowance shall be properly classified as Productivity Enhancement Incentive (PEI) and shall be subject to Budget Circular No. 2017 – 4 dated December 4, 2017;

3. That the appropriation for Other Personnel Benefits of city officials and employees shall not be disbursed until such time that the circulars granting the same shall be issued by the proper authorities;
4. That the appropriation for Performance Based Bonus (PBB) of city officials and employees under the Urdaneta City University (UCU) shall be disbursed pursuant to the provisions of the corresponding circulars granting the same;
5. That the employer (government) share in the premium contributions to the Home Development Mutual Fund (Pag-IBIG Fund) of the city officials and employees shall be adjusted pursuant to DBM Circular Letter No. 2024-2 dated February 1, 2024;
6. That the disbursement of appropriations for Terminal Leave Benefits and Monetization of Leave Credits shall be subject to the provisions of DBM Budget Circular No. 2016-2 dated March 29, 2016 re: "Computation and Funding of Terminal Leave Benefits and Monetization of Leave Credits, which provides for the new constant factor stated under Item 3.1 thereof";
7. That the appropriation for the purchase of motor vehicle/s under the Local Economic Enterprise and Urdaneta City University shall be subject to the provisions of Budget Circular No. 2022 – 1 of the Department of Budget and Management dated February 11, 2022 re "Omnibus Guidelines on The Acquisition, Use, Rental, and Replacement of Government Motor Vehicles";
8. That the effect of Final FY 2024 National Tax Allotment (NTA) shares of the city necessitate the prioritization in the implementation of items of appropriations of the LGU;
9. That the items funded out of the Local Disaster Risk Reduction and Management Fund shall be in accordance with R.A. No. 10121 known as the Philippine Disaster Risk Reduction and Management Act of 2010 and its IRR, and the DBM - NDRRMC - DILG Joint Memorandum Circular No. 2013-1 dated March 25, 2013 re Allocation and Utilization of the Local Disaster Risk Reduction and Management Fund (LDRRMF);
10. That the projects funded under the 20% of the Annual National Tax Allotment for development projects (20% Development Fund) shall be subject to the provisions of DBM - DOF - DILG Joint Memorandum Circular (JMC) No. 1 dated November 4, 2020 re: "Revised Guidelines on the Appropriation and Utilization of the twenty percent (20%) of the Annual Internal Revenue Allotment for Development Projects";

11. That all programs, projects and activities shall be in accordance with the approved Local Development Plan and FY 2024 Annual Investment Program of the city formulated pursuant to DILG - NEDA - DBM - DOF Joint Memorandum Circular No. 1, Series of 2007 dated 08 March 2007; and
12. That all procurements to be undertaken shall be subject to the pertinent provisions of R.A. No. 9184 (The Government Procurement Reform Act) and its revised Implementing Rules and Regulations.

WHEREAS, the Sangguniang Panlalawigan after final evaluation, finds the same in order provided that the findings shall be complied with by the City;

WHEREFORE, in view of the foregoing, on motion of SP Members Rosary Gracia P. Perez-Tababa and Nicholi Jan Louie Q. Sison and co-sponsored by SP Members Carolyn D. Sison, Joyce D. Fernandez and Raul R. Sabangan, duly seconded, it was—


