## **RESOLUTION NO. 608-2024**

DECLARING MUNICIPAL ORDINANCE NO. 184-020523 OF THE SANGGUNIANG BAYAN OF VILLASIS, PANGASINAN, ENTITLED "AN ORDINANCE RECLASSIFYING FIVE THOUSAND TWO HUNDRED THIRTY NINE (5,239) SQUARE METERS, MORE OR LESS, OWNED BY JEA STEEL INDUSTRIES, INC. SITUATED AT BARANGAY BARRACA, VILLASIS, PANGASINAN COVERED UNDER TCT NO. 026-2021003335 FROM AGRICULTURAL LAND TO COMMERCIAL/INDUSTRIAL USE" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT

WHEREAS, the Sangguniang Bayan of Villasis, Pangasinan submitted its Municipal Ordinance No. 184-020523 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer, Provincial Planning and Development Coordinator and the Department of Human Settlements and Urban Development have conducted initial review and study on said municipal ordinance and found out that the the subject Ordinance is within the conferred powers of the sanggunian to enact, provided there is compliance with the requirements mentioned in Section 20 of R. A. No. 7160 and those enumerated in Memorandum Circular No. 54;

WHEREAS, the requisite of public hearing has been complied with and nobody posed no objection on the reclassification of the subject land area;

WHEREAS, the Municipality of Villasis has an existing and approved Zoning Ordinance implementing its Comprehensive Land Use Plan CY 2013-2022;
