**WHEREAS**, Supplemental Investment Program No. 3 contains other priority programs, projects and activities that were not included in the approved 2024 Annual Investment Program of the Province of Pangasinan;

**WHEREAS**, programs and projects included in the said Supplemental Investment Program covers fund augmentation for Personal Services, Other Maintenance and Operating Expenses and Capital Outlay of provincial offices and hospitals as well as implementation of other priority programs and projects of the province to be funded under Special Purpose Appropriations;

**NOW, THEREFORE**, on motion of SP Member Vici M. Ventanilla, duly seconded, it was –


