RESOLUTION NO. 611-2024

DECLARING MUNICIPAL ORDINANCE NO. 25-2023 OF THE SANGGUNIANG BAYAN OF ANDA, PANGASINAN, ENTITLED “AN ORDINANCE REPEALING MUNICIPAL ORDINANCE NO. 02, SERIES OF 2004 (THE COMPREHENSIVE ECOLOGICAL SOLID WASTE MANAGEMENT ORDINANCE OF THE MUNICIPALITY OF ANDA, PANGASINAN), SUBJECT TO ALL LEGAL AND EXISTING RULES AND REGULATIONS” AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG TO ENACT

WHEREAS, the Sangguniang Bayan of Anda, Pangasinan submitted its Municipal Ordinance No. 25-2023 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer have conducted initial review and study on said ordinance and found out that the same was enacted in accordance with Article II of the 1987 Philippine Constitution; RA 8749 or Clean Air Act of 1999; RA 9003 or Solid Waste Management Act; RA 9275 or Clean Water Act; and Sections 16, 17 (a) (2) (vi) and 447 (1) (iii) (vi) of R. A. No. 7160;

WHEREAS, the subject ordinance shall take effect after compliance with the requirement of publication pursuant to Section 511 (a) of R.A. No. 7160;

WHEREFORE, in view of the foregoing, on motion of SP Members Napoleon C. Fontelera, Jr. and Apolonia DG. Bacay and co-sponsored by SP Members Carolyn D. Sison, Joyce D. Fernandez and Raul R. Sabangan, duly seconded, it was—


