**RESOLUTION NO. 614-2024**

**DECLARING ORDINANCE NO. 085, S-2024 OF THE SANGGUNIANG BAYAN OF LABRADOR, PANGASINAN, ENTITLED "AN ORDINANCE REGULATING THE USE OF PUBLIC ROADS, ALLEYS, PARKS AND OTHER THOROUGHFARES IN THE MUNICIPALITY OF LABRADOR, PANGASINAN" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT**

**WHEREAS**, the Sangguniang Bayan of Labrador, Pangasinan submitted its Ordinance No. 085, S-2024 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer have conducted initial review and study on said municipal ordinance and found out that the same was enacted in accordance with Sections 21 & 447 (a) (1) (5) (v) of R. A. No. 7160 and Article 43 of its Implementing Rules and Regulations; Department of the Interior and Local Government Memorandum Circular Nos. 2019-121 and 2020-027, Re: Continued Implementation of the Presidential Directive to Clear Roads of Illegal Obstructions (Road Clearing 2.0);

**WHEREAS**, the subject ordinance shall take effect after compliance with the requirements of posting and publication pursuant to Sections 59 and 511 of R.A. No. 7160;


