S-2024 OF THE DECLARING **ORDINANCE** 087, LABRADOR. PANGASINAN. SANGGUNIANG BAYAN OF "AN **ORDINANCE** ON COLLECTION ENTITLED CORRESPONDING BARANGAY CLEARANCE FEE IN THE APPLICATION FOR ANY BUSINESS RELATED TRANSACTIONS WITHIN THE MUNICIPALITY OF LABRADOR, PANGASINAN" AS WITHIN THE CONFERRED POWERS OF THE SANGUNIAN TO **ENACT** 

WHEREAS, the Sangguniang Bayan of Labrador, Pangasinan submitted its Ordinance No. 087, S-2024 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer have conducted initial review and study on said municipal ordinance and found out that the same was enacted in accordance with Section 447 (3) (i) of R. A. No. 7160 and Section 11(f) of RA 11032 "An Act Promoting Ease of Doing Business and Efficient Delivery of Government Services";

WHEREAS, the subject ordinance shall take effect after compliance with the requirement of publication pursuant to Section 188 of R.A. No. 7160;
