RESOLUTION NO. 616-2024

APPROVING RESOLUTION NO. 798, S-2024 OF THE SANGGUNIANG BAYAN OF LINGAYEN, PANGASINAN, ENTITLED "A RESOLUTION APPROVING THE SUPPLEMENTAL INVESTMENT PROGRAM (SIP) NO. 1, CY 2024 OF THE MUNICIPALITY OF LINGAYEN, PANGASINAN"

WHEREAS, the Sangguniang Bayan of Lingayen, Pangasinan submitted its Resolution No. 798, S-2024 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No.7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said Resolution with the following findings:

1. The Municipal Development Council of Lingayen, Pangasinan prepared their Supplemental Investment Program (SIP) No. 1 for CY 2024. This was endorsed by the Council, through MDC Resolution No. 01, Series of 2024 dated February 20, 2024, to the Sangguniang Bayan for approval. This is in accordance to Sections 106, 109 and 114 of the Local Government Code of 1991;
2. The Supplemental Investment Program, which has a total investment requirement of ₱75,124,804.17, covers the augmentation of funds for Personal Services, Maintenance Other Operating Expenses and Capital Outlay, and implementation of development projects and LDRRM projects/activities.

3. The projects proposed to be funded from the 20% Development Fund, conform with Joint DBM-DOF-DILG Memorandum Circular No. 1 dated November 4, 2020 (Revised Guidelines on the Appropriation and Utilization of the 20% of the Annual Internal Revenue Allotment for Development Projects).

Likewise, the projects proposed to be funded from the LDRRM Fund are based on Joint Memorandum Circular No. 2013-1 of the NDRRMC, DBM & DILG dated March 25, 2013 (Allocation and Utilization of the Local Disaster Risk Reduction and Management Fund) of the LGU;

4. Funding for the Supplemental AIP is embodied in the LGU's Supplemental Budget No. 01, CY 2024, which was enacted by their Sangguniang Bayan through Appropriation Ordinance No. 01, S-2024 dated April 29, 2024.


WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of Lingayen, Pangasinan;

WHEREFORE, in view of the foregoing, on motion of SP Members Philip Theodore E. Cruz and Haidee S. Pacheco and co-sponsored by SP Members Carolyn D. Sison, Joyce D. Fernandez and Raul R. Sabangan, duly seconded, it was—


