RESOLUTION NO. 617-2024

DECLARING THE SUPPLEMENTAL BUDGET NO. 1 FOR CALENDAR YEAR 2024 OF LINGAYEN, PANGASINAN INVOLVING A TOTAL APPROPRIATIONS OF P75,124,804.17, OPERATIVE IN ITS ENTIRETY

WHEREAS, pursuant to Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the Sangguniang Panlalawigan of Pangasinan as a legislative body of the Province is empowered to review ordinances authorizing annual or supplemental appropriations of component cities and municipalities in the manner prescribed by law;

WHEREAS, the Sangguniang Bayan of Lingayen, Pangasinan submitted its Supplemental Budget No. 1 for Calendar Year 2024 involving total appropriations of P75,124,804.17, which was enacted on April 29, 2024 through Appropriation Ordinance No. 01, S-2024;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Local Finance Committee of the Province pursuant to Section 316 of the Local Government Code of 1991, have conducted review and study on said budget with the following findings:

1. That the funding sources for the subject supplemental budget were determined in accordance with the provisions of Section 321 of R.A. 7160 and Article 417 (a) of its IRR as amended by Administrative Order No. 47 dated April 12, 1993;

2. That all programs, projects and activities shall be in accordance with the approved Local Development Plan and the FY 2024 Annual Investment Program of the municipality and its supplements thereto, formulated pursuant to DILG-NEDA-DBM-DOF Joint Memorandum Circular No. 1, Series of 2007 dated March 8, 2007;
3. That all procurements to be undertaken shall be subject to the pertinent provisions of R.A. No. 9184 (The Government Procurement Reform Act) and its Revised Implementing Rules and Regulations;
4. That the utilization of appropriations from 20% Development Fund shall be in accordance with the provision of DBM-DOF-DILG Joint Memorandum Circular (JMC) No. 1 dated November 4, 2020 re: Revised Guidelines on the Appropriation & Utilization of the 20% of the Annual Internal Revenue Allotment for Development Projects;
5. That the disbursement of additional One Thousand Pesos P1,000.00) in Uniform/Clothing Allowance shall be in accordance with Budget Circular No. 2024-1 dated April 4, 2024;
6. That the employer (government) share in the premium contributions to the Home Development Mutual Fund (PAG-IBIG FUND) of municipal officials and employees shall be in accordance with the provisions of DBM Circular Letter No. 2024-2 dated February 1, 2024; and
7. That the grant of Representation and Transportation Allowances (RATA) to municipal officials shall be in accordance with the Local Budget Circular No. 157 dated May 03, 2024.

WHEREAS, the Sangguniang Panlalawigan after final evaluation, finds the same in order provided that the findings shall be complied with by the municipality;

WHEREFORE, in view of the foregoing, on motion of SP Members Philip Theodore E. Cruz and Haidee S. Pacheco and co-sponsored by SP Members Carolyn D. Sison, Joyce D. Fernandez, Raul R. Sabangan, duly seconded, it was—

RESOLVED, as it is hereby resolved, by the Sangguniang Panlalawigan in session assembled, to declare Operative in its Entirety Supplemental Budget No. 1 for Calendar Year 2024 of Lingayen, Pangasinan;






