### **RESOLUTION NO. 618-2024**

#### APPROVING RESOLUTION NO. 812, S-2024 OF THE SANGGUNIANG BAYAN OF LINGAYEN, PANGASINAN, ENTITLED "APPROVING THE REVISED ANNUAL INVESTMENT PROGRAM (AIP) FOR CY 2024 OF THE MUNICIPALITY OF LINGAYEN, PANGASINAN"

WHEREAS, the Sangguniang Bayan of Lingayen, Pangasinan submitted its Resolution No. 812, S-2024 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No.7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said Resolution with the following findings:

- 1. The Municipal Disaster Risk Reduction Management Council, through MDRRM Council Resolution No. 02, Series of 2024, dated February 8, 2024, proposed for projects to be funded from the Unexpended Balances of LDRRM Fund (CYs 2021-2023) of the LGU, in the amount of P10,000,000.00;
- 2. This was integrated in the Revised AIP for CY 2024 which was prepared and endorsed by the Municipal Development Council of Lingayen, Pangasinan through MDC Resolution No. 02, Series of 2024, dated February 20, 2024, to the Sangguniang Bayan for approval. This is in accordance to Sections 106, 109 and 114 of the Local Government Code of 1991;

- The projects proposed to be funded from the Unexpended Balances of LDRRM Fund are based on Joint Memorandum Circular No. 2013-1 of the NDRRMC, DBM & DILG dated March 25, 2013 (Allocation and Utilization of the Local Disaster Risk Reduction and Management Fund); and
- 4. The preparation of the Revised AIP is in pursuance to Sections 6.4 and 6.5 of the NDRRMC-DILG-DBM JMC No. 2013-1 dated March 25, 2013, to quote:

Section 6.4 The unexpended LDRRMF shall accrue to a special trust fund solely for the purpose of supporting disaster risk reduction and management activities of the Local Disaster Risk Reduction and Management Council (LDRRMC) within the next five (5) years.

Section 6.5 The unexpended balances of the LDRRMF may be released and utilized for new expenditure items upon submission of a revised AIP as approved by the Local Sanggunian and Local Chief Executive (LCE) upon recommendation of the LDRRMC in accordance with the approved LDRRMP;

WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of Lingayen, Pangasinan;

WHEREFORE, in view of the foregoing, on motion of SP Members Philip Theodore E. Cruz and Haidee S. Pacheco and co-sponsored by SP Members Carolyn D. Sison, Joyce D. Fernandez and Raul R. Sabangan, duly seconded, it was-

**RESOLVED**, by the Sangguniang Panlalawigan in session assembled, to approve Resolution No. 812, S-2024 of the Sangguniang Bayan of Lingayen, Pangasinan, entitled "Approving the Revised Annual Investment Program (AIP) for CY 2024 of the Municipality of Lingayen, Pangasinan";
