RESOLUTION NO. 622-2024

APPROVING SB RESOLUTION NO. 77, S-2024 OF THE SANGGUNIANG BAYAN OF MANAOAG, PANGASINAN, ENTITLED “APPROVING THE 1ST SUPPLEMENTAL INVESTMENT PROGRAM FOR CALENDAR YEAR 2024 OF THE MUNICIPALITY OF MANAOAG, PANGASINAN”

WHEREAS, the Sangguniang Bayan of Manaoag, Pangasinan submitted its Resolution No. 77, S-2024 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No.7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said Resolution with the following findings:

1. The Municipal Development Council of Manaoag, Pangasinan prepared the municipality’s 1st Supplemental Investment Program for CY 2024. This was endorsed by the Council, through MDC Resolution No.01, Series of 2024 dated January 25, 2024, to the Sangguniang Bayan for approval. This is in accordance to Sections 106, 109 and 114 of the Local Government Code of 1991;
2. Said Supplemental Investment Program (SIP), which has an investment requirement of ₱240,000,000.00, covers the implementation of the LGU project, Construction of a New Two-Storey Public Market with Parking Area; and

- Funding for the SIP will be sourced from the Trust Fund (loan proceeds from LBP) as embodied in the LGU's Supplemental Budget No. 1, FY 2024, which was enacted by their Sangguniang Bayan through Appropriation Ordinance No. 01, Series of 2024 dated March 26, 2024.


WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of Manaoag, Pangasinan;

WHEREFORE, in view of the foregoing, on motion of SP Members Marinor B. De Guzman and Jerry Agerico B. Rosario and co-sponsored by SP Members Carolyn D. Sison, Joyce D. Fernandez and Raul R. Sabangan, duly seconded, it was—


